### **Covid update**

As we see our current lockdown ease and the pandemic move into a more passive phase and hopefully decline along with the local public agencies.

I intend to discuss with all my parish councils their views and contributions to local recovery of the community as we all face the reality of what returning to some form of normality means.

### **Seasonal workers to receive free Covid-19 tests on farms – release dated 1<sup>st</sup> April 2021**

The government has called on employers of seasonal agricultural workers to help keep the nation safe and restrict the spread of Covid-19 by registering for free workplace testing.

This follows [the introduction of a new bespoke testing regime for international arrivals](#) this weekend, which extended the supply of free Lateral Flow Device (LFD) tests to employers of seasonal agricultural workers in the edible horticulture sector. These workers play a vital role across many of our farms, picking fruit and vegetables and helping to feed the nation.

Seasonal agricultural workers will be able to access these tests through several routes, including home testing and community testing. They should remain on the farm for the 10 days after they arrive.

**County firms urged to sign up for staff home testing kits**

Herefordshire businesses, unable to offer their employees workplace COVID-19 rapid testing, are being encouraged to sign up to a new system enabling them to obtain home test kits for staff.

The government initiative is open to any business with more than 10 employees and, to take part, they will have [to register](#) by 11.59pm on Monday April 12. The workplace testing programme will, from Tuesday April 6, begin supplying home test kits to eligible companies where it is not possible to set up testing on-site due, for example, to a lack of space or because companies operate across multiple locations.

Once registered, they can order the kits online to distribute to their employees. These self-test kits will enable staff to complete the home test and report their results to the NHS. Clear instruction are provided with the kits.

### **Shielding for clinically extremely vulnerable people lifted**

Thousands of Herefordshire residents, considered to be clinically extremely vulnerable (CEV), will no longer have to follow the current guidance on shielding from April 1.

Around 11,000 people in the county have been taking extra measures to protect themselves from COVID-19 but, with the virus case numbers currently low and the rollout of the vaccination programme, the government is lifting its restrictions and the guidance for CEV is changing.

Those in the CEV category will receive a letter in the next two weeks notifying them they can start following national restrictions alongside the rest of the population from April 1. It will include advice to help reduce their risk of catching COVID-19.

Steps to minimise risk include maintaining strict social distancing, keeping their overall social contacts at low levels and working from home where possible.

*county. All A, B and major C roads in the county are inspected monthly to ensure safety and information from these and other inspections informs the development of the Annual Plan.*

*The priorities for the coming year have been developed to align with the council's County Plan, and will focus on drainage following a difficult period which has seen the county affected by several flooding events. There will also be work on structures, including significant bridge works. General maintenance activities will continue, but this focus is possible because of the additional investment that has been made into carriageway surfacing over the past year and the overall condition of the road network.*

### **New High Sheriff for Herefordshire**



Jo Hilditch from the Whittern in Lyonshall is the fourth generation of her family to become High Sheriff of Herefordshire.

She runs the family farming business which includes the production of blackcurrants and the liqueur Cassis which she has developed, and chairing the Herefordshire Farmers Club. She also has holiday letting business and chairs the Visit Hereford group who help promote tourism in the county. She has made many TV appearances including Dragons Den and recently on Salvage Hunters.

The office of High Sheriff is one of the oldest in land created over a thousand years ago, just after the Norman Conquest by monarchs to help keep the peace in the Kingdom, and

support the Judges in the administration of law and order. The earliest Lyonshall resident I can find holding the office was John Melbury in 1404 who also seems to have served a further seven times which is most unusual.

The High Sherriff is the second most senior resident of the County after the Lord Lieutenant. The office is held for one year, is non-political and unpaid, with the appointment made by the Sovereign herself in an ancient ceremony where the name of the appointed person is pricked by a silver bodkin on a parchment.

These days the office is still used to support the local judicial and magisterial functions but also the blue light services and voluntary organisations. In particular Jo has indicated she wants to support the overall local recovery from the recent pandemic particularly supporting mental health in agriculture and young people.

### **Culture Boost for North Herefordshire**

North Herefordshire will receive £203,859 to support iconic cultural and heritage organisations as they reopen and recover from coronavirus.

Across the country, more than 2,700 culture and heritage organisations and independent cinemas are being supported to survive and thrive with nearly £400 million.

This is part of the unprecedented Culture Recovery Fund, worth almost £2 billion, the largest one-off investment in the arts in our history.

### **County leisure centres receive funding boost**

The National Leisure Recovery Fund from Sport England supports publicly owned leisure facilities through the coronavirus crisis. Herefordshire Council has received £460k to allocate to Halo Leisure to help secure the future of these important community venues located across the county in Hereford City, Bromyard, Kington, Ledbury, Leominster, Kington, Ross. This is the maximum amount that could have been allocated and seeks to allow leisure facilities to reopen to the public.

Halo is a social enterprise and like many registered charities has struggled financially during the ongoing pandemic.

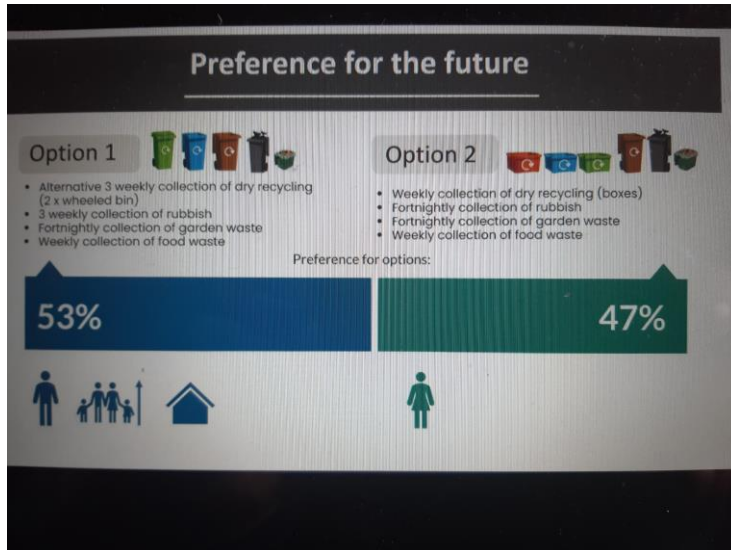

### Domestic Waste consultation



The weekly collection contract is up for renewal in 2023 and the disposal contract in 2024 and residents will recall that I alerted you to a consultation earlier this year on the future of your collection. The council received over 3,500 responses and using weighted data (reflecting the demographic profile of the population) the preference for options where as indicated in the picture alongside.

The weekly bin service is one of the most popular services the council has with 99% take up and I modestly will take credit for its introduction when I was Leader of the council.

Currently the most recycled materials are plastic, thin card, paper, food tins, and glass bottles. The most frequent items that should not be placed in the bins include plastic film, textiles and batteries. There was strong support for including food waste in the new contract; and also for green garden waste but not for paying for it.

Residents indicated they preferred a leaflet / calendar as the best form of communication and advice. Discussion will continue on the new specifications of the contract which I will feed back

### Council Tax precepts for all Herefordshire residents.

As the billing authority, the council has a statutory duty to collect charges set by each parish council, the Police and Crime Commissioner for West Mercia and Hereford & Worcester Fire Authority. However, Herefordshire Council has no control over the level of increase or how these organisations choose to spend their budget.

Herefordshire residents will be provided with individual bills based on their parish location. The raised precepts are needed to support the delivery of vital services across the county, with the average Council Tax bill for a band D dwelling set at £2,051.61.

This includes the council's own tax charge of £1,652.30 (for a Band D dwelling) which was approved by Full Council on 12 February 2021 - the equivalent of £31.78 per week. The precept for the Police and Crime Commissioner for West Mercia rose by £14.94 to £240.19, an increase of 6.66%. The precept for Hereford & Worcester Fire Authority rose by £1.69 to £87.68, an increase of 1.97%.

Residents on a low income may be eligible for help to pay their bill through the Council Tax Reduction scheme. Some residents will continue to pay no Council Tax at all, such as young adults who have left care and also all the council approved Foster Carer families.

### **Fly Tippers prosecuted**

Herefordshire Council has won an Enforcement case against two friends who were found guilty of fly tipping two loads of waste which were found dumped on Bromyard downs and in a layby near to Acton Green crossroads.

John Hodgkins (40) of Redstone Lane, Stourport-On-Severn and Isaac Janes (48) of 78 Layman Walk, Stourport-On-Severn both pleaded guilty to two counts of fly tipping at Hereford Magistrates' Court on 9 March 2021. The pair received fines and costs totalling £1072.00 each.

**Apply for a Postal Vote - Local by-elections and Neighbourhood**

Just to remind you, in the future there will be the normal council elections in Herefordshire in early **May 2023** and if you can't get to your polling station for whatever reason, or do not want to vote in person at a polling station, you can apply for a postal vote but you must be registered under Individual Electoral Registration first. - Note the fly tippers' clothes, and distinguishing features. If you can hear the fly tippers, take note of anything which was said along with the speakers' accents
- Make a note of what they dumped, the location, weather conditions and how far away you were at the time
